1. POST MATRIC SCHOLARSHIP FOR SC/ST/OBC WEST BENGAL (OASIS) ONLINE APPLY

- Website: oasis.gov.in
- Any SC/ST/OBC Student of our College can apply.
- The Annual income of parents/guardians of the applicant (from all sources) should be less than or equal to ₹ 2.5 Lakh per Annum.
- The applicant must not be availing any other scholarship by the govt.

2. SWAMI VIVEKANANDA MERIT-CUM-MEANS SCHOLARSHIP FOR GENERAL STUDENTS ONLINE APPLY

- Website: svmcm.wbhed.gov.in
- Student Must obtain 60% marks (75% Marks for 2020 Pass out) in Last qualifying examination.
- The Annual income of parents/guardians of the applicant (from all sources) should be less than or equal to ₹ 2.5 Lakh per Annum.
- The applicant must not be availing any other scholarship by the govt.

3. AIKYASHREE SCHOLARSHIP/ SWAMI VIVEKANANDA MERIT-CUM-MEANS SCHOLARSHIP FOR RELIGIOUS MINORITY ONLINE APPLY

- Website: wbmdfcscholarship.in
- Any Religious minority students of our College can apply.
(Muslims, Sikhs, Christians, Buddhists, Jain and Zoroastrians
(Parsis))
- The Annual income of parents/guardians of the applicant (from all sources) should be less than or equal to ₹ 2 Lakh per Annum & ₹ 2.5 Lakh per Annum for swami Vivekananda merit-cum-means scholarship.
- The applicant must not be availing any other scholarship by the govt.
- Scholarship will not be given to more than two students from a family.
- Applicant must have secured not less than 50% marks or equivalent grade in the previous final examination.

**KANNYASHREE PRAKALPA
ONLY FOR GIRLS
OFFLINE APPLY**

- Girls Students between ages 18-19 of our College can apply for K2 One-Time Grant of Kanyashree Prakalpa.
(Require Birth Certificate issued by Municipal or Panchayat authorities)
- Applicant must be Unmarried (Require certificate by a govt. Authority)
- Upgradation Cases where girls have received one or more instalments of the Annual Scholarship (K1) in School, and are now eligible to apply for the One-Time Grant (K2) as they have turned age 18 and meet other eligibility criteria.

DOCUMENTS REQUIRED

1. Student's Photo.
2. Institution Verification Certificate
3. Income Certificate, issued from a Competent Authority in the State/UT Govts is required in respect of parent/guardian of the student.
4. Minority/Caste Certificate.
5. Self-attested Mark Sheet of the last qualifying exam.
6. Fee Receipt of 'Current Course Year'.
7. Bank Details (Account No., IFSC Code) of the applicant.
8. Residential / Domicile Certificate.
9. Aadhaar Card(or alternative identification documents)
10. "Bonafede Student Certificate" from the institute (if the institute is located in a State/UT different from domicile State/UT)
11. Declaration of the Student (if Required)
12. Baptism Certificate for Christians Students.
